The company has two cotton yarn spinning units (1) established at Petlad, Dist. Anand, Gujarat and (2) situated at Borgaon, Dist. Chhindwada, M.P. Both the units had to close operational activities under the State Government and the Central Government directions / instructions on account of COVID 19 Pandemic. The brief information in this regards is given here under:


Since the company has to continue its Operational Activities keeping in view the follow of Govt. Guideline and safety of the workers the situation and continuous operational activities (without interruption) cannot be ascertained at this stage it all depends on the situation.

Due to lockdown and Covid-19 effect, cotton yarn consumption in the country is expected to shrink by 25-30%. Most of the local customers of the company are small, medium enterprise, who have yet to resume their operation. Future prices and sales is uncertain due to various unforeseen factors. Our customers are spread all over India. Every state has different lockdown policy. So, it is difficult to predict the impact on the Company.

Due to continuous lockdown in the areas of our branch offices at Kolkata, Nagpur, Bombay and Delhi, the finalization of the audited accounts remains uncertain. All efforts will be made to complete audited account and Board Meeting before 30.06.2020.
