# Proceedings of 104<sup>th</sup> Annual General Meeting of the Company held on 25<sup>th</sup> September, 2023.

The 104<sup>th</sup> Annual General Meeting ("the meeting") of the members of PBM Polytex Limited was held on Monday, the 25<sup>th</sup> September, 2023 at 11:00 A. M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

The Chairman, Shri Krishan Kumar Patodia, had sought leave of absence and therefore, on the proposal of shareholders, the Managing Director, Shri Gopal Patodia, occupied the Chair. The Chairman of Audit Committee and Stakeholders Relationship Committee, Shri Ashok Pandit, was also present.

The Company has 4907 shareholders holding 68,79,020 shares as on 18.09.2023 (Cut-off date for the purpose of entitlement of E-Voting facility). There being 38 members present in person, though VC, including representatives, if any, the quorum was in order. The Chairman informed that the Participation of Members through VC is being reckoned for the purpose of Quorum as per the Circulars issued by the Ministry of Corporate Affairs (MCA) and Section 103 of the Companies Act, 2013 (the Act).



The Managing Director, Shri Gopal Patodia addressed the shareholders on Financial Performance of the Company, current economic situations and problems of Cotton Spinning Units and its impacts.

The Chairman thereafter informed that the copies of audited financial statements for the year ended March 31, 2023, Directors' Report and Auditors' reports had been emailed, to all the Members whose email ID are registered in the Company's Records and that the original documents along with the Statutory Registers and Secretarial Auditors' Report were available for inspection through electronic mode. The Chairman further informed the shareholders that e-voting facility had been provided to all Members to vote electronically, from 22<sup>nd</sup> September, 2023 at 9:00 a.m. (IST) to 24<sup>th</sup> September, 2023 at 5:00 p.m.(IST), on all the resolutions set forth in the Notice of AGM and that there would be no voting by show of hands at the meeting. Members who were present at the AGM and had not casted their vote electronically prior to the date of AGM, were provided an opportunity to cast their votes electronically during the AGM. Members who have casted their vote by remote e-voting prior to the AGM, were entitled to attend the AGM but were not entitled to cast their vote again.

He further informed that M/s. Samdani Shah & Kabra, Practicing Company Secretaries, Vadodara were appointed as scrutinizer for the purpose of scrutinizing the remote e-voting process.

Thereafter, it was informed to the Members that there were no qualifications, observations or comments on financial transactions or matters or in the Secretarial Audit Report, which had any adverse effect on the functioning of the Company. Accordingly, no part of Auditor's Reports including Secretarial Auditor's Report were required to be read at the Meeting.

Thereafter, the Chairman informed the Members that the Notice convening 104<sup>th</sup> AGM was already circulated to all the Members and the same can be taken as read with the permission of the members.

Thereafter, Shri Gopal Patodia, Chairman, invited the members to raise their queries, if any / on the financial results or any agenda item.

Thereafter, the following resolutions were put to vote electronically as ordinary resolution/special resolution.
